I'm sorry.

00:00:38:14 - 00:00:39:04

Yeah.

00:00:39:04 - 00:00:44:14

No, I just spent, good part of the day traveling in other cities.

Down in, Salt Lake County, in Utah County and Davis County looking at parks, recreation and, capital upgrades of facilities

and learning best practices from each of their staffs and looking at ideas that we can bring back to Ogden,

including new and different ways of looking at funding models,

partnerships and leveraging partnerships and contracts through private parties and so on.

And we will provide the kinds of assets and experiences that we're all after.

That's that's great to hear.

Yeah. I, I know that this was yeah, I remember how many months ago, weeks ago, months ago it was.

But obviously the Taylor Canyon School property has been a hot topic.

And I know you've met with the neighbors there, to talk about, you know what? What they'd like to see there.

But when you spoke with city council at city Council about it, a little while later, you were talking about obviously

doing an audit of all the parks. Is that kind of part of this right now to see exactly what overall we need? Yeah.

For the betterment of the city. Right.

So we are in fact, they talked about a lot of the same type of study

that we're doing, and they even referenced the same data sources

that we use to figure out,
like park usage and pressures and, patterns, timing,

00:01:59:16 - 00:02:05:16

how many and and when and why,
and looking for areas of high utilization and low.

And why is it low. Right. And why is this one high?

And they shared a lot of their findings and how they make more informed investments, and decisions around their park spaces

based on those sorts of studies.

And so we're in the
we're in the process of, of getting armed with information.

And that's really going to help us make a lot better decisions
because we have,

I don't know, call me in the number,
but I think we have like 44 parks in our city.

Really? Yes. We have a ton of parks and other cities don't have that.

And so it's interesting because that seems to be, a big sticking point
that you hear a lot right now is,

00:02:42:18 - 00:02:48:03

you know, open space, open space for some space.
It sounds like we've got more open space than than most.

Oh, yeah.

00:02:48:10 - 00:02:53:18

Maybe it's just not being utilized
or or built up the way that it can be utilized the best.

That kind of like. Okay, so you use the term open space. Yeah,
I use the term parks.

They're actually accounted for differently in our records
and in our plans. Right.

And that's important
because people often associate and assume that the same.

And so today we were looking at parks and open space in other cities.

And our plans call for a certain metric of our general plan
calls for two acres, per thousand residents.

And our recreation master plan calls for three.

00:03:20:09 - 00:03:24:09

And we're exceeding the two by I think we're at 2.98 right now.

So we're like point two away from our goal in the recreation
master plan, and we're crushing the general plan goal.

But what we found is that we are actually categorizing
those two things differently.

And so our metrics don't include a lot of our trails
and our open space on the mountain side.

And I was visiting none of the cities
I visit today had nearly the proximity and access that we do right.

And so we've got to be really mindful in how we start talking about it,

because we've not on purpose,
but we've recognized that there's distinct distinctions.

And that's an important distinction.

The point is that we have a ton of parks,

00:04:04:21 - 00:04:07:22
not they're not amenities the way people want.

00:04:07:22 - 00:04:12:15
So is that Taylor Canyon area.
Is that being included right now in your. Yes, yes.

And your numbers? Yes.

00:04:13:20 - 00:04:15:19
But it's not amenities basically.

Correct. It does. It has very minimal.

So Taylor Canyon specifically, there's a, you know, the former,

Taylor Canyon Elementary School is a parcel that's up for discussion
for, for a new park.

And some people call parks open space.

00:04:31:03 - 00:04:37:02
And so but if you look at our park distribution, it's right
in between two parks.

Yeah. Right.

00:04:38:12 - 00:04:44:12
So there's Thomas Park and Lions Park
and what you want to know why those two parks aren't being used.

Because there's not a lot of use. Right.

And how do we leverage use when there's a lot of demand.

And it's pretty clear that none of those three areas
are offering the kinds of amenities that people would use.

I think that's probably what the finding will be.

And that's kind of the case.

I mean, we've got different patterns of use around the city in different patterns of amenities.

Right, right. And activation through events, sports, right, community events, etc..

Mount Ogden Park is used a lot. It's busy, busy, busy, right? Yeah.

I'm really curious how busy that is compared to other parks too.

Because we have a lot of parks and and what parts of our city are we serving and under?

00:05:24:16 - 00:05:25:16

Serving.

00:05:25:16 - 00:05:31:15

And our initial assessments have shown over the years that we're under serving the north side of town.

And that's important because, a lot of the engagement we get is from the east side and on the south end.

So we hear a lot of talk about Taylor Canyon, and that's important.

We're going to get we're going to engage. We're going to do good things.

But what about the North Side isn't engaging and it's being underserved.

And it's our job to make sure that we're serving and representing the people that are not here to speak for themselves.

Yeah, that's the underserved parts of communities that don't engage in the same ways.

And when you need to be making sure that we're engaging and serving the people that need it most, too.

And it's interesting because the people who do show up to,

you know, speak out, they also believe that they're serving the people that aren't speaking.

Right, right. Or that aren't there.

It's it's it's fascinating because we kind of when you've gone through that with other issues.

Oh yeah. That time. Right. Controversial.

Yeah. But what they don't know.

And like

we just had an example right before we started recording that we got good news that we got another person housed

and that was a person that came to us to me. Yeah, asking for help.

And it was through a connection that we made through
community engagement, particularly in the Marshall White neighborhood.

And that's an area of need. But it was a
that introduction needed to happen.

And it's less about seeing things online and more about having
that human connection that meet the person where they're at.

Yeah.

And when we do that, and we get to leverage my seat of authority
and power that comes with it, we can help people a lot. Yeah.

And so we have resources that are out there always doing it.

And we often funnel them in through my office
to through our engagement efforts as well as through police, etc..

And we can

get people housed time and time and time again.

Yeah, it's kind of stuff that you don't hear about, right?

You don't talk a whole lot about on online. No.
And I'm not going to because that's private for that person. Correct.

It's important we say keep privacy.

00:07:19:14 - 00:07:19:19
Yeah.

00:07:19:19 - 00:07:26:06
And it's interesting because and I've been on you know, I've seen
both sides of it where, you know, I'll read something online and go like

what?

How dare they or how, how can the city do that or something like that?

And, what's nice now is usually seen across from me on the couch.

I'm like, hey, is this what's happening here? And you can like,
that's not what's happening.

Here's what's happening. And kind of lay it out.

And, and I think when we

you talked with City Council about it, a few weeks ago,
just kind of the national rhetoric that we've been seeing on both sides.

Right, right, right.

And the and I think everybody knows that it is damaging our, our country over all this national rhetoric.

And both sides are equally at fault. Right.

Because we're always trying to get whatever influence they feel like they need to get.

Well based on an issue at the national level.

00:08:12:10 - 00:08:18:19

Yeah, it's it's so I mean, it wasn't just me talking about a few weeks ago that you've heard a lot of people talking about it.

The governor's been talking about it a ton.

00:08:20:03 - 00:08:25:15

He's been talking about for years, but it really ramped up, especially after the Charlie Kirk incident. Right. And so,

following the governor's lead, you've seen lots of editorials and newspapers, different community

00:08:32:09 - 00:08:39:08

leaders from from across the spectrum talking about we need to take a timeout in the social media sphere

00:08:39:08 - 00:08:45:12

and the attention that it's getting it from us, and the kind of energy and toxicity and divisiveness that it's creating.

Now, there's a big difference between toxicity and rhetoric and divisiveness, etc.,

00:08:52:15 - 00:08:58:12

that are driven by algorithms through social media, right, and driven by, agendas, etc.

whether that agenda is from an industry, from a personal agenda, a political agenda, a partisan or party agenda, whatever it is.

Those those algorithms have been completely hijacked and totally optimized in order to drive what those,

00:09:14:16 - 00:09:17:02

those users know

00:09:17:02 - 00:09:21:10

that reinforces it, reinforces that drives it, and it itches

the scratch, you know, that scratches these little itches that we have because they know that negative energy and anger

are much easier, right, right.

00:09:31:04 - 00:09:32:09

To to inflame.

Right.

00:09:32:20 - 00:09:38:11

And so when you see something, I mean, there's been times when I've seen something and I'll just be like immediately

just how. Right, right.

And when the facts actually come out,
it's it's much more benign usually.

And it's boring. Not always. You know, there is wrongdoing out there.

No doubt, no doubt.

And there are politicians out there
that deserve the kind of focus they get.

You know what I mean? Right.

And it but I will just say I sat on a panel
I mentioned this in City Council on Tuesday, Senate a panel on Tuesday.

Earlier in the day with other elected officials.

00:10:06:13 - 00:10:12:13
And and they said the same thing that I said,
they're like, look, in my experience,

00:10:12:15 - 00:10:20:02
the overwhelming majority of elected officials and public officials,
elected or not, are good, decent, wholesome people trying to do good.

And and often overwhelmingly doing good.

00:10:23:21 - 00:10:27:01
But the algorithms will make you think otherwise.

00:10:27:01 - 00:10:30:11
And that's not to get you to stop scrutinizing me, right?

00:10:30:11 - 00:10:34:10
Like, scrutinize me, hold me accountable.
That's what that's fine. I'm totally comfortable with that.

But here's here's I think what the difference is.

And I think part of it obviously is because I get to sit next
to whenever you finally come home from whatever meeting you're at,

and when I see something,
I can ask the question. Sure. Right, right. And I think

we tend to

00:10:51:17 - 00:10:58:04
believe first something that you see and assume it's it's accurate

00:10:59:07 - 00:11:03:21
because sometimes some of the language can get a little bit,
you know, confusing.

Right. And rather than question where they get that information from,
we believe it.

00:11:09:08 - 00:11:18:16
And then secondly, rather than like question your elected leaders, like
what does this mean, what this person said this or I saw this online,

explain this to me. So I'll give you an example.

You had a one of the big things you talked about
at the last city council meeting at was, just how much Ogden is doing,

00:11:32:07 - 00:11:38:23

for homelessness and,
you know, deeply affordable housing in the county.

And compared that to, what other cities within
the county are or are not doing right.

00:11:47:09 - 00:11:53:22

And there was a question
that was brought up at a later date or later time about,

00:11:53:22 - 00:12:01:03

well, he's not actually being truthful about this
because the state get the all these cities give us perfect model or so.

So what I did last night, I said, what is what is
what is this person talking about \$4.5 million coming from these cities.

00:12:08:22 - 00:12:13:11

And so you explained it to me and it made sense.

00:12:13:11 - 00:12:19:08

It made sense. And then I still I was able to find the
the document that this person got their information from.

So I'm going to ask you to explain it to me again like I'm five.

Okay. So we do probably more than 82%

00:12:29:17 - 00:12:33:01

of the homelessness and deeply affordable housing in the county.

00:12:33:01 - 00:12:37:12

Right. Going through your GIS information tools that you have.

00:12:37:12 - 00:12:40:10

And the next closest city is about 5%.

00:12:40:10 - 00:12:43:17

Yeah. So the 82% came from a third party source.

That's not me just making it up or reading through our records.

But what I found out yesterday
through GIS confirmation is that it's possible that numbers actually low

where if if I didn't has 82% of the,

00:12:59:15 - 00:13:05:19

shelter beds
and permanently subsidized and deeply affordable and etc., housing.

Yeah, we're only 32% of the of the county population.

00:13:10:16 - 00:13:12:14

I think it's actually higher than 82%. Right.

00:13:12:14 - 00:13:16:14

And then that in addition to the next closest city being 5%.

00:13:16:14 - 00:13:19:00

And that there are six cities that are 0%.

00:13:19:00 - 00:13:24:09

And then there's another which would make seven. That's .0. 1%.

00:13:24:09 - 00:13:26:05
It's effectively zero. Yeah.

00:13:26:05 - 00:13:30:16
The point is it's no one's helping. Right.

00:13:30:16 - 00:13:33:00
And I think you made that point very, very clear.

00:13:33:00 - 00:13:38:16
So the comment was and oh, about the mitigation,
about the mitigation, of.

00:13:38:16 - 00:13:42:08
Well, yeah. But and and the comment the state reimburses.

00:13:42:08 - 00:13:46:08
Well, no,
what they said the other cities or surrounding cities, 4.5 million.

00:13:46:08 - 00:13:51:08
So that should help all of the costs that you had outlined. Right.

And then this with it, this gets to the point that,

00:13:54:13 - 00:13:56:10
you know,

00:13:56:10 - 00:13:58:05
there will always be critics. It's fine.

That's kind of the job. It's I guess it's part of accountability.

00:14:01:03 - 00:14:07:02
But what what that comment is referring to
is the is the mitigation fund.

00:14:07:05 - 00:14:11:19
And know that the cities around us are getting very little.

00:14:11:19 - 00:14:18:09
What that is, is a collection of all cities in the state that are not,
shelter cities or shelter city.

00:14:18:16 - 00:14:23:04
And every other city that doesn't host one has to pay into that fund.

00:14:23:04 - 00:14:26:20
But when you spread it out
amongst that many cities, it's actually very little.

00:14:26:20 - 00:14:32:04
And I've talked to many, many mayors who are like, oh,
we're more than happy to cut that small check every year.

00:14:32:04 - 00:14:32:14
Yeah.

00:14:32:14 - 00:14:38:14
Not to deal with things from the check to the, you know,
so they each have to say no, it's different per city.

00:14:39:01 - 00:14:44:01
I think it's based or something like that. It's it's in statute,
whatever those criteria are, I don't recall.

00:14:44:01 - 00:14:49:19
But every single year at the capital,
we have to fight for keeping those funds because that fund is always

00:14:49:19 - 00:14:52:14
kind of under attack to be used for other things. Right, right.

00:14:52:14 - 00:14:55:06
So you have to basically lobby. Yes.

00:14:55:06 - 00:14:58:04
So you've got your people from Ogden
that are lobbying for that. So, right.

00:14:58:04 - 00:15:03:17
This last year
we got 4.5 some odd million dollars about that. Something like that.

00:15:03:17 - 00:15:04:13
Is that

00:15:05:17 - 00:15:08:12
does that help with what we're dealing with? Yes.

00:15:08:12 - 00:15:14:07
I mentioned that in my comments on Tuesday. Right.
I said that the state helps to cover some of these cosmos.

00:15:14:07 - 00:15:15:03
Not enough.

00:15:15:03 - 00:15:19:11
And I said these are just some of the costs
I was able to find before I came with me.

00:15:19:11 - 00:15:24:22
I had a handwritten notes of some of the things I was finding it. Right.
I mean, I'm not it's not completely complete. Right.

00:15:24:22 - 00:15:27:09
And I and I mentioned a number of things like the,

00:15:27:09 - 00:15:33:22
like the homeless court and what like the biggest vandalism
and the repairs to the vandalism in the ft.

00:15:34:06 - 00:15:38:09
In Parks and Rec to have to respond to all that, like,
what does it cost?

00:15:38:09 - 00:15:43:14
You have to close our bathrooms and the families can't use them
while they're playing at the park because of the vandalism.

00:15:43:14 - 00:15:44:06
What's the cost?

00:15:44:06 - 00:15:49:22
There isn't one.
You can't put a dollar cost on the impacts to a victim of these crimes.

00:15:49:22 - 00:15:54:10
I mentioned all of the crimes that identity police are responding to,
and how many of them require follow up

00:15:55:13 - 00:16:00:19
that many of those are multiple repeat chronic follow up?

00:16:00:19 - 00:16:03:16
There's clearly a trend there. Right.

00:16:03:16 - 00:16:05:04
So the costs just continue to mount.

00:16:05:04 - 00:16:11:07
And so that four point whatever million that the state gives us
from the other cities, it's not even close to covering the cost

00:16:11:07 - 00:16:18:11
and the impacts, not just on the city,
but what about the cost, the impacts on you as taxpayers and park users.

00:16:18:15 - 00:16:20:11
Right. That's the point.

00:16:20:11 - 00:16:26:23
So but it also it fits really neat and snug in a nice little talking
point and a nice talking point because the mayor's a liar or whatever.

When it's incredibly complex, it's everything's complex.

00:16:30:20 - 00:16:34:02
That's why when you I know this is this is why I brought all this stuff.

00:16:34:02 - 00:16:37:11
It's like accounting. I don't I don't even want to think about that.

Right.

00:16:39:06 - 00:16:43:00
And I don't want to have to either. But I need to.
And I've got people that help me do this.

Right. And, because the like

00:16:47:13 - 00:16:49:15
this is the struggle.

00:16:49:15 - 00:16:51:20
Getting back to this national issue,

00:16:51:20 - 00:16:57:20
every city is dealing with it now and we are dealing with it
more than ever in our own city, especially during silly season.

Right. It just comes up.

00:16:59:12 - 00:17:03:01
And so I'm getting buried with questions around,

00:17:03:01 - 00:17:07:17
are you really, corrupt in the way you finance? Are they questions.

00:17:07:17 - 00:17:09:07
Are they accusations, accusations?

00:17:09:07 - 00:17:11:10
You might mind questions. I don't mind questions.

00:17:11:10 - 00:17:12:05
No, of course not.

00:17:12:05 - 00:17:19:16
But when it's an accusation or a conspiracy theory that's floated
and it's it's just surprising to me how quickly people will believe that

versus just ask, ask the question like,
how does this work? Right. And I'm not

like, I can handle this.

00:17:28:11 - 00:17:31:07
I'm not a victim of any kind of it's just this is the real world.

But what we're what we're talking about
is highlighting the need for us all, myself included,

to be critical thinkers
when it comes to the information that we're consuming right there.

These algorithms are in.

These talking points are crafted to anger us and to accuse right without

accurate information

or even evidence, like I've been called in the newspaper,

like referred to as a criminal,
that I'm, that I'm whatever bribes this that the other.

It's not just the newspaper. No. It's everywhere.

So but that but those sort of accusations in in the past
would require evidence.

There isn't
there isn't any evidence. No. It's just what it it's feels right.

00:18:10:20 - 00:18:16:01
And because I'm not like a public official
that that apparently is fair game, but I hold myself and,

from the city council to ensure transparency and accountability.

And it clearly outlines

And when I say ordinance, I'm talking about law, city law that,

doesn't mean we're not accountable.

So we are required to answer to a third party auditor.

Every year. That auditor is hired by the city council to audit us.

In me, it's my responsibility
to make sure that we're following all these things, right?

And more involved than you think.

But I know about these things because I know of all this.

And that third party presents an audit findings or audit summary. Right.

And yet outside this room, there's a wall with a plaque

in accounting that we that we show here.

People should feel confident in what we're doing.

Not because I say so right,
but because the Oregon City Council holds me accountable

and that I'm not going to wait until we get there to be like,
oh yeah, I'll fix it.

I'll fix I make promises. No. Yeah. Third party verified. Yeah. Right.

When people have complaints
about how a budget item or line out or whatever it is, how it's spent.

tell me was the auditors have said that that meets standards of the.

Yes, absolutely.

how the city chose to do this or that.
